
Global Manager Commentary

The MSCI ACWI rose 4.19% in February, mainly supported by well-received corporate earnings. Equities continued their upward trend, led by a strong US market, which saw the S&P 500 and the tech-heavy Nasdag closing at all-time highs during the month. US headline inflation fell back to 3.1% YoY in February, down from 3.4%. Core inflation, fell only slightly to 3.9% over the year, suggesting that price increases are staying more stubborn than expected. The global bond Index sold-off for a second continuous month, in stark contrast to the equity market, returning (1.19%) in February.


